

Dual Credit Partnerships

FAQ: Do we HAVE to partner with the community college for our education region?

TAC 74.25 states that a school district may adopt a policy that allows a student to be awarded credit toward high school graduation for completing a course provided by an institution of higher education that is accredited by one of the following regional accrediting associations:

- (1) Southern Association of Colleges and Schools;(2) Middle States Association of Colleges and Schools;
- (3) New England Associating of Schools and Colleges;
- (4) North Central Association of Colleges and Schools;(5) Western Association of Schools and Colleges; or
- (6) Northwest Association of Schools and Colleges.

Texas School Districts are allowed to partner with ANY IHE that is accredited by one of the regional accrediting associations listed above, regardless of the location!

Many Texas School Districts partner with more than ONE IHE.



DUAL CREDIT PARTNERSHIPS CONSIDERATIONS

Can we limit the number of dual credit courses our students enroll in?

No, House Bill (HB) 505 prohibits limiting the number of dual credit courses or hours in which a student may enroll while in high school and the number of dual credit courses in which a high school student may enroll during a single semester or academic year (TEC §28.009)

Who decides the number of high school credits a student receives for a dual credit course?

Shouldn't the dual credit course cover ALL of the TEKS??

The school district decides the alignment and credit assigned to each dual credit course.

The student expectations in the TEKS describe a level of knowledge and skill that is expected of a student upon completion of that high school course. The course for which college credit is awarded must provide advanced academic instruction beyond, or in greater depth than, the essential knowledge and skills for the equivalent high school course (TEC 74.25 (b)).



"The biggest structural barrier to increasing college completion rates and career success in the United States is the enduring and seemingly intractable disconnect between high school, higher education, and our workforce systems" (JFF, 2021).

What & Who

The FAST program, as outlined in <u>Texas Administrative Code (TAC)</u>, <u>Chapter 13</u>, <u>Subchapter Q</u>, provides funding to participating public institutions of higher education so they can offer dual credit courses to educationally disadvantaged students at no cost to these students.



Educationally Disadvantaged?

Students eligible for the national free/reduced-price lunch program. A student who meets this requirement in any of the four school years prior to the academic year in which the student is enrolled in the eligible dual credit course may be eligible for the FAST program.



How much does FAST pay?

he FY 2025 (2024-2025) tuition rate is \$56.87 per semester credit hour (or equivalent).

The FAST tuition rate adopted by the THECB serves two purposes:

• Funding rate: Participating institutions will receive an allotment of funding equal to the FAST tuition rate for each semester credit hour (or equivalent) of dual credit coursework taken



What about students who are NOT Educationally Disadvantaged?

• Maximum tuition rate: Participating institutions that have an agreement with an ISD or charter school may not charge a per-credit tuition rate more than the FAST tuition rate to any student attending high school in a Texas school district or charter school for any eligible dual credit course offered by the participating institution. Institutions may choose to charge a lower rate for any or all dual credit coursework without impacting the funding rate.

TEC CH. 74 B. Graduation Requirements

i. Courses offered for dual credit at or in conjunction with an institution of higher education that provide advanced academic instruction beyond, or in greater depth than, the essential knowledge and skills for the equivalent high school course required for graduation may satisfy graduation requirements, including requirements for required courses, advanced courses, and courses for elective credit as well as requirements for endorsements.

TEC CH. 74 B. Graduation Requirements

(p) A school district shall permit a student to comply with the curriculum requirements under the Foundation High School Program by successfully completing appropriate courses in the core curriculum of an institution of higher education (IHE). A student who has completed the core curriculum of an IHE in accordance with TEC, §61.822, as certified by the IHE in accordance with §4.28 of this title (relating to Core Curriculum): (1) is considered to have earned an endorsement by successfully completing the appropriate courses for that endorsement; (2) is considered to have earned a distinguished level of achievement under the Foundation High School Program; and (3) is entitled to receive a high school diploma



Smart Alignment

Young people have mixed opinions on K-12 education as it currently stands, with 38% stating K-12 schools are on the "right track," 40% stating they are on the "wrong track," and 22% unsure. The areas they say are in need of greatest improvement are providing "career or jobs skills."

About 84% of high school students report that they want to go to college, but only 68% of students expect to attend.15 Some of this drop-off may be due to lack of awareness: 63% of students say they wish their high school provided more information about postsecondary education opportunities.

Problem 01

K-12 Schools

- 40% of young people state K-12 schools are on the "wrong track"
 - **38%** of young people state K-12 schools are on the "right track"
 - **22%** of young people state they are unsure

Problem 02

College Interest and Awareness

- 84% of high school students want to go to college
- 68% of high school students expect to attend college
- 63% of high school students wish more information was provided

Texas First Program

House Bill 8, 88th Texas Legislature, Regular Session, 2023, establishes that a school district is required, rather than permitted, to issue a high school diploma under the Texas First Early High School Completion Program if the student demonstrates mastery of and early readiness for college in accordance with Texas Higher Education Coordinating (THECB) board rules. The statute does not authorize a school district to impose any additional requirements, including, for example, requiring a student to notify a district of their election to participate in the program earlier than the semester in which the student earns the diploma or limiting the students who may earn the diploma to juniors or seniors.

Eligibility for Texas First Diploma

Prohibitions

School districts and charter schools may not -

- impose any additional requirements on a student who wishes to graduate with a Texas First diploma;
- require a student to notify the school of their election to participate in the program earlier than the semester in which the student earns the diploma; or
- only permit students classified as juniors or seniors to earn a Texas First diploma.

Diploma Equivalency

A student who graduates early through the Texas First Early High School Completion Program is considered to have earned a diploma with a distinguished level of achievement under Texas Education Code §28.025. The school must provide each student who earns a program diploma with a designation of distinguished level of achievement on the student's diploma.

Texas First Program - Mandatory Notification

Upon a student's initial enrollment in high school, each public high school must provide a written notification to each high school student and the student's parent or guardian regarding the requirements to earn a high school diploma under the program and the Texas First Scholarship Program and listing the eligibility criteria for the Texas First Early High School Completion Program and Texas First Scholarship Program. (19 TAC Part I, §21.54)

The notice must include information about the requirement that a student must provide an official copy of their assessment results and transcripts, as applicable, to receive credit for the assessments and credits required to graduate with a Texas First diploma.

The Texas Higher Education Coordinating Board has provided a <u>flyer</u> that can be used by school districts and charter schools as notification to students and families.

In you graduate two or more semesters before your class, you'll receive a two-semester scholarship, equivalent to the amount of the TEXAS grant, upon admission to any Texas public institution of higher education, including colleges, universities, and technical colleges. You may also be eligible for additional financial aid at most of these institutions!

The Texas First Diploma does not guarantee automatic admission for students. Ask your counselor if your grade point average at graduation qualifies you for automatic admission under the state's top 10 percent law.

You can apply to any college or university you choose; however, the scholarshipwill apply only at the Texas public institution of higher education where you have been admitted.

Use it or lose it! The scholarship offer will expire at the end of the first academic year following your graduation, so we encourage you to attend college directly after high school.

NOTE: Before September 1, 2023, the Texas First Scholarship was only applicable at 10 Texas public universities. However, effective September 1, 2023, the number of

eliaible to award the Texas First Scholarship to eligible Texas Firs Diploma graduates expanded from nstitutions of higher education. ncluding colleges, universities, and technical colleges (Senate Bill 2294, 88th Texas Legislature, Regular Session). Please see your high school counselor for information reazraina eliaibility requirements to araduate early under the Texas First Program and receive a scholarship up to one year upon admission to any eligible Texas public institution of higher education, per Texas Education Code, Section 61.003.

- Require guided pathways!
